**Engagement of Technician (Diploma) Apprentices (under Apprentices Act, 1961) at Government Polytechnic Jagatsinghpur, Odisha**

Government Polytechnic Jagatsinghpur is a Government institution of Odisha, established in the year 2017 at Jamugaon, Naugaon Block, Jagatsinghpur, Odisha. It is affiliated to State Council of Technical Education & Vocational Training (SCTE&VT), Odisha and under the administrative control of Directorate of Technical Education and Training (DTE&T), Odisha, Cuttack under the Department of Skill Development and Technical Education, Government of Odisha, Bhubaneswar. This institution is approved by All India Council for Technical Education (AICTE), New Delhi and imparts three year Diploma Engineering course in Mechanical, Civil, Chemical and Electrical Engineering.

Government Polytechnic Jagatsinghpur is inviting applications from the eligible candidates who are domiciles of Odisha only for an Apprenticeship Training Programme of one year at the premises of the institution. During the period of Apprenticeship training, the candidates are governed by Apprentices Act, 1961 (as amended in 1973 and till date) and commensurate policies/rules of the institution.

**B. Educational Qualification**

Candidates should possess full time three years (regular) diploma in Engineering in the above mentioned streams recognised and approved by AICTE.

### **C. Conditions**

1. As per the provisions of the Apprentices Act, 1961 as amended from time to time, candidates who have already completed their apprenticeship or terminated their apprenticeship midway or are pursuing in other organizations, shall not be eligible for engagement as apprentice.
2. As per the Apprentices Act, 1961, candidates who had apprenticeship training/job experience for a period of 1 year or more after the attainment of essential qualifications, shall not be eligible for engagement as apprentice.

### **D. Eligibility Criteria**

1. Only Indian nationals who are domiciles of Odisha only.
2. Candidates passed diploma in 2020 or after 2020 are eligible.
3. Age limit: Minimum age is 18 years and Maximum age is 26 years as on 31.03.2024.

### **E. Mode of Selection**

1. The shortlisting of the candidates would be based on percentage (%) of marks in the Diploma examination.
2. The shortlisted candidates will be called for Interview/Document verification.
3. The final selection will be based on Interview/verification of certificates and submission of Medical Fitness Certificate at the time of joining.

### **F. General Instructions**

1. **Last date of application is 16.03.2024.**
2. The interested candidates are required to apply through NATS 2.0 portal [www.nats.education.gov.in](http://www.nats.education.gov.in) by finding establishment GOVERNMENT POLYTECHNIC JAGATSINGHPUR (Enrolment ID: EORJSS044917).
3. Candidates should register themselves with the concerned NATS 2.0 portal prior to applying for apprenticeship training without fail. Applications received online through NATS 2.0 portal will only be considered. Correspondence/communication in any other manner will not be entertained.
4. Government Polytechnic Jagatsinghpur has no obligation to give regular employment to apprentices. They shall have no right to claim regular employment from the institution on the basis of this apprenticeship at any point of time.
5. The decision of institution will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process either in part or full, etc. No correspondence will be entertained in this regard. Filling up of the seats is solely at the discretion of the institution

based on suitability of candidates and no claim will be entertained, if some of these seats are not filled due to unsuitability/insufficient number of candidates.

6. The candidature of the applicant would be provisional, subject to verification of all certificates and submission of certificate of Medical Fitness (to be obtained only from a Government Medical officer/Medical Officer of a Government Undertaking) at the time of joining.
7. At any stage of selection process, if it is found that the candidate has furnished false or incorrect information, then the candidature/engagement of the candidate is liable to be cancelled.
